SIX FREQUENTLY ASKED QUESTIONS

WHY DID WE DECIDE TO MOVE?

Unity on the Bay has been moving toward a vision for a new home that was originally birthed as a part of a strategic plan initiated in 2013. June 4, 2015, became an auspicious day in the 90-year history of our community when the overwhelming majority of members present voted to approve a recommendation to sell our current property, utilizing funds to create a new home for our ministry as we move forward in faith toward the next chapter of our ministry's long life. Since then we have completed the sale and moved our services to Temple Israel and our offices nearby at 2800 Biscayne Blvd. The goals of this process are to acquire or develop a facility that fulfills our vision, secure the financial future of Unity on the Bay, and achieve a seamless transition to a new property with minimal interruption. Each day we grow closer to the manifestation of the vision that originated after a lengthy process that engaged congregants, leadership and staff.

We will not be able to answer that question thoroughly without exploring our options. However, we can say, it can be 1-3 years. We have gratefully found a wonderful transitional house that meets our needs. This will afford us the time to find the right and perfect new location.

WHAT AREAS ARE WE CONSIDERING FOR A NEW LOCATION?

We are looking at the greater Miami metropolitan area. We do not have a specific radius in mind.

ARE THERE ANY SITES LOCATIONS CURRENTLY UNDER CONSIDERATION?

We have not narrowed it down to a particular location at this time. We are open to looking at different options. We are not in a rush and market conditions are in our favor.

WILL WE BE CHANGING OUR NAME?

Since we are no longer "on the bay," we are considering the options of keeping the name or changing it. That will be determined once we find our new location.
